- You must submit the child's immunization record at the time of registering for High Holiday childcare. Your registration is not complete without an immunization record, and your child will not be admitted without a complete registration.
- If your child is enrolled in Religious School with a current copy of their immunization record, you do NOT have to resubmit the immunization record when you register for High Holiday youth programs.
